
The purpose of the meeting is to consider and act upon the following items:

Section 551.071 For the purpose of private consultation between the District and its attorney when the attorney's advice with respect to pending or contemplated litigation settlement offers, and matters where the duty of the District's counsel to his client pursuant to the Code of Professional Responsibility of the State Bar of Texas clearly conflicts with the Open Meetings Act.
